## UNIFIED CALL 02/2021 FOR FREE REGISTRATION FOR PARTICIPATION IN LAWCN'21:

### III LATIN AMERICAN WORKSHOP ON COMPUTATIONAL NEUROSCIENCE

This call addresses regulations regarding submission of applications, selection process, implementation, and usage of free registration to remotely or presentially participate in the LAWCN 2021 ([www.lawcn.com.br](http://www.lawcn.com.br)), which will be held in the city of São Luís, MA – Brazil, from December 8<sup>th</sup> to 10<sup>th</sup>, 2021. Due to the COVID-19 pandemic, it is going to be a hybrid event, i.e. a face-to-face and online event. Participants can remotely or presentially attend it.

This call is granted by the International Brain Research Organization (IBRO) Diversity Grant and due to a collaboration with NeuroTechX.

#### 1 – TARGET AUDIENCE / ELIGIBILITY

This call is directed to anyone that aims to participate in the III Latin American Workshop on Computational Neuroscience (LAWCN'21) but cannot afford its registration.

IBRO grant is devoted to women's participation (foreign participant)

- 1) Women diversity: women graduate and undergraduate students enrolled in courses and scientific activities in any of the fields of the Workshop. They must reside in a Latin American country (not in Brazil);
- 2) Regional diversity: women graduate and undergraduate students enrolled in courses and scientific activities in any of the fields of the Workshop. They must reside in others countries (not in Brazil neither a Latin American country).

For NeuroTechX community members, anyone (men and women) can apply:

- 1) Graduate and undergraduate students enrolled in courses and scientific activities in any of the fields of the Workshop. They must reside in a Latin American country (not in Brazil);
- 2) Regional diversity: graduate and undergraduate students enrolled in courses and scientific activities in any of the fields of the Workshop. They must reside in others countries (not in Brazil neither a Latin American country).

Once a goal of this call is to increase regional diversity, Brazilians are not eligible to participate.

## 2 – DEADLINE FOR GRANT APPLICATION AND RESULTS NOTICE

Applications for this call must be **submitted until November 24<sup>th</sup>, 2021** (Brazilian time).

Results will be announced on **November 30<sup>th</sup>, 2021** or before by e-mail to the candidates.

## 3 – APPLICATION INSTRUCTIONS

To apply for the selection process, candidates must send an e-mail to [lawcn@ufma.br](mailto:lawcn@ufma.br) with the subject “CALL 02/2021 LAWCN <Name of candidate>” with an attached motivation letter (no longer than one page) containing the following information:

- Full name and gender;
- City, state (department), and country of residence;
- Affiliation: full name (including department/division if existent) of university, research institute, company or the condition of self-employed;
- In the case of students, graduate program or undergraduate course;
- Previous experience in research groups and publications in topics related to the event;
- Why you should receive it;

The selection process will be carried out by a committee composed of members of the Workshop Organizing Committee and NeuroTechX staff, who will evaluate candidates on the basis of all documentation and information provided, but with special attention to the enrollment and productivity of the applicant on the areas of the conference.

Applications with incomplete documentation will not be taken into consideration in the selection process.

## 5 – FREE REGISTRATION

The free registrations will be distributed according to the following system:

IBRO support for women:

- Two (02) quotas for undergraduate student;
- One (01) quota for graduate student;
- One (01) quota for professional.

NeuroTechx support:

- Ten (10) quotas for undergraduate student;
- Seven (07) quotas for graduate student;
- Three (03) quotas for professionals.

## 6 – FINAL REMARKS

Candidates do not need to be registered in the Workshop when submitting the application in order to successfully participate in the selection process.
